Meet Microsoft Agent 365

Microsoft Agent 365 is the enterprise control plane for AI agents, a centralized platform to discover, observe, govern, secure and manage agents across the organization, regardless of where they were built. It supports agents from Microsoft Copilot, Copilot Studio, Azure AI, Power Platform and third-party solutions. Agent 365 is included in Microsoft 365 E7, the Frontier Suite, and is also available as a standalone license.

By extending existing Microsoft 365 and Microsoft Security capabilities, Agent 365 enables IT and Security teams to enforce governance, manage identities and access, monitor activity, protect data and control agent lifecycles at scale – giving organizations the confidence to move from experimentation to enterprise-wide adoption.

Five Core Governance Capabilities



1. Registry & Discovery

Create a complete inventory of all agents across your organisation, including Microsoft, custom and third-party agents.

Know what exists.



2. Identity & Access Control

Manage secure agent identities and enforce least-privilege access policies.

Control who can access what.



4. Governance, Security & Compliance

Enforce governance policies, protect sensitive data and maintain compliance using Microsoft Security capabilities.

Protect data and reduce risk.



3. Observability

Monitor agent activity, usage and behaviour in real time.

Gain complete visibility.



5. Lifecycle Management

Manage the full lifecycle of AI agents, from deployment through ongoing governance and retirement.

Maintain control at scale.
